1. Introduction

Auto Bolt is committed to protecting your personal information. The purpose of this Privacy Policy is to outline how we deal with any personal information you provide to us which is either collected by us through this website (“www.autoboltusa.com”) (“**Website**”) and/or via the services we provide to you.

Auto Bolt is the controller of your personal information via our Website and the services we provide.

Collection of Your Personal Information

We may process your personal information when you submit it to us in the following ways:

Communications via our Website: We collect personal information when you provide it to us through communications via our Website. This includes where you have contacted us through the “Contact Us” page on our Website, entry forms, and similar situations in which you have chosen to provide the information to us, including for customer service support.

Products or Services you request: When you request a good or service from us, we will collect your personal information to process your request and otherwise contact you following a purchase.

Cookies

Auto Bolt Website may use cookies and similar technologies (together referred to as “cookies”, unless otherwise stated) to provide you with an efficient experience in using our Website.
